

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to the www.thepatientsproject.org and The Patients' Project, Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to The Patients' Project, Inc. include www.thepatientsproject.org, TPP, PhillyNETs and www.phillynets.org. The TPP website is a Information, list of services, news, sales of awareness items, links to other sites of interest site. By using the TPP website, you consent to the data practices described in this statement.

Collection of your Personal Information

TPP may collect personally identifiable information, such as your name. If you purchase TPP's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by TPP. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the TPP website.

Use of your Personal Information

TPP does not sell, rent or lease its customer lists to third parties.

TPP may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to TPP, and they are required to maintain the confidentiality of your information.

TPP may keep track of the websites and pages our users visit within TPP, in order to determine what TPP services are the most popular. This data is used to deliver customized content and advertising within TPP to customers whose behavior indicates that they are interested in a particular subject area.

TPP will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on TPP or the site; (b) protect and defend the rights or property of TPP; and, (c) act under exigent circumstances to protect the personal safety of users of TPP, or the public.

Security of your Personal Information

TPP secures your personal information from unauthorized access, use or disclosure.

Children Under Thirteen

TPP does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.
